

2024 British Columbia Votes Survey Results

October 2, 2024

About the Survey

- 1,000 interviews completed: 500 interviews with Greater Vancouver Board of Trade members and 500 interviews with a random sample of Metro Vancouver residents,18 years of age or over;
- Mustel Group's Giving Opinions panel used (100% randomly recruited panel) supplemented by panel partner Sago to ensure the sample is representative of the population;
- Minor weighting applied to sample of residents by gender within age, and region to match Statistics Canada Census data;
- GVBOT member survey conducted late August and residents' survey mid-September.



















Government Meeting Services and Infrastructure Needs for Population Growth



Q.C3) How much is B.C.'s housing situation impacting your business?








Safety in Greater Vancouver Compared to 5 **Years Ago**







How Traffic and Congestion Changed Over Past 4 Years











Q.F3) What barriers are hindering your business' ability to adopt new Al/technologies?








Will B.C. have Adequate Energy Supply to Meet **Demand in Next 10 Years**




Should Province Intervene on Governance of Metro Vancouver








Q.J1) What sector does your business/ organization operate in?




Q.J2) In which municipality is your business located? If your business has multiple locations, please select all that apply.



Land/ Space Usage

















Q.C) Into which of the following age categories do you fall?


